THE TECH CENTER PROVIDES OUT-OF-SCHOOL-TIME STEM-RELATED SCIENCE, TECHNOLOGY, ENGINEERING, MATH) PROGRAMS FOR YOUTH. THE SPACE IS APPROXIMATELY 5,000 SQUARE FEET IN SIZE.
